I have just seen six UFOS whilst driving home. I am sure there is a good explanation and would like to check if you had military craft on exercise in the area to this number.

At 12:31 this evening, approx half an hour ago I saw 6 lights almost in an S shape slowly moving across the sky. I was on the road FROM Humberston (suburb of Cleethorpes) to Tetney, North East Lincs. I was on the straight just before Tetney village when I saw through my cars front window these 6 lights. I've never seen anything like them, it just looked very odd. I pulled over and got out to look further. They were moving in formation from West to north east (towards the sea). The conditions were misty in the sky, although at ground level it was clear. Then one of the lights disappeared quickly. I got back into the car to follow the lights and pulled over again further along. Only two lights remained and gradually faded out. I would like to note that there was NO sound.

I would like this to be anonymous, you are welcome to contact me discreetly but I do not want the media to know of me or my name as I run several businesses and have a reputation to consider. I have taken several photographs on my phone but can not examine them or blow them up until I get back into office as I have left cable there.

I would appreciate knowing if you had six helicopters in the area at this time or have I seen a genuine UFO formation?

I can assure you that the Ministry of Defence (MOD) appreciates your concerns and takes most seriously its' departmental aim to deliver security for the people of the United Kingdom and the Overseas Territories by defending them and acting as a force for good by strengthening international peace and security.

On 26 February the MOD launched the dynamic Defence Technology Plan (DTP) available online at [www.science.mod.uk](http://www.science.mod.uk) to enable transparent prioritisation and coherence across MOD's R&D programme. The DTP aims to encourage fresh and innovative thinking, to demonstrate the value of the research programme to Defence and to enable more effective working across the R&D community. This is a cost-balanced expression of research priorities for the MOD that takes forward the Defence Technology Strategy (DTS), published in October 2006.

I have had my colleagues in the Science Innovation Technology area conduct an assessment of your proposal. The outcome this assessment is that they are satisfied that our capability to ensure the air defence of the UK can be delivered without the need for new equipment. The MoD is not complacent about the integrity of the UK's airspace which is maintained through continuous surveillance of the UK Air Policing Area by the Royal Air Force. This is achieved by using a combination of civil and military radar installations, which provide a continuous real-time "picture" of the UK airspace. Any threat to the UK Air Defence Region would be handled in the light of the particular circumstances at the time (it might if deemed appropriate, involve the scrambling or diversion of air defence aircraft).

From that perspective, reports provided to us of 'UFO' sightings are examined, but consultation with air defence staff and others as necessary is considered only where there is sufficient evidence to suggest a breach of UK air space. The vast majority of reports we receive are very sketchy and vague. Only a handful of reports in recent years have warranted further investigation and none revealed any evidence of a threat. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for UFO sightings if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

As I am sure you can imagine, the Secretary of State and the Chief of Air Staff are both extremely busy and it will not be possible for them to speak with you.

I have believed in these crafts since my school days and now I have proof of these UFO's in photo's & videos since 1996 right up to 2009 from my back door all my photos & videos are through the day of very good light and all were taken between 11-00am & 4-30pm two I spotted @ night being a very good clear moon light night in between a large gap in the clouds over Chapel Cross heading towards Edinburgh as also I made a model of this UFO as did the first one but is of a very different shape some also taken while out walking with a friend when I was in Eastriggs going over a railway bridge when it buzzed an old ww11 tempest plane thought the pilot did not know it @ the time which happened on the 1<sup>st</sup> of June 2009 @ about 12-30 & 1pm the video shows the shape and the speed I come to is of a 6<sup>th</sup> of a second of the time it came into our airspace &

back out, this I used the time from the length of time it showed upon video & disappears after if had a good look @ the plane it also left on the dive & turning a slip stream I also made paintings taken from prints from the video I made 7 prints as which was the number of frames in the video of appearing & disappearing.

I would be happy to for any one to pay a visit to my place and I can show you all that I've taken and the most recent ones from out my back door just a few weeks ago I saw two jets leave a vapour trail in the shape of a "v", then I also notice three UFO's that look like out of "Star Wars Film" they had me glued to the ground just watching them that I nearly forgot my camera in the kitchen as I have two or three near hand 2 digitals & one SLR Camera it was the SLR one I used but the third one was too far behind I managed to get one shot and forgot to put the camera on several frames per second so I was not quick enough to take the next shot as they all disappear before I could & then could not say how they manage to disappear before my eyes it was like magic I think they were the mother of all UFO's they look like battle ships that you see in old war films.

The other two photo's are of the plane being buzzed & the others is of a RAF jet going round above my house several times on a very clod cloudy day around 4pm plus there were 4 UFO's playing with the jet I used my digital cam camera & also saw one that kept coming out from behind the clouds while the others hid behind thin layers of clouds but still saw them with my eyes as well with the camera and I followed the jet as it went round the area before heading I think for Spade Adam if that's the right spelling?

I could go on and on describing all in detail but it would take up a lot of pages and a lot of ink so if any one from the RAF/MOD wish to pay a visit and watch the videos and see that these UFO'S are genuine space crafts and I do not go by what the majority that seem to see them @ night and tell what lights are seen, I know that strobe lights on planes & helicopters move right round them from wing tip to tail as similar with the copter, I've seen copters almost every night in the area from the Solway coast and around Annan of Chapel Cross even high altitude planes are mistaken for them as well though they should note the speed of the plane and then they should know that it is a space craft of the speed it does from a to b take the area, time and of course if it's a very dark cloudy night or a very clear moon light night as with through the day as well, I see all the ones through the day 9 times out 10 they all seem to be around when ever there are planes it is I think rare for one to be very low and just glide as the one I first saw in 1996/98.

I may have a computer but I'm not on the internet as @ the moment I can't afford it as I'm busy doing the house and my garden plus what bills come in I hope to start some time next year so that I can't look into UFO sightings from other people in the country.

If possible to send this to the mod as I do not know which department of the MOD to send this type of letter to them I would be very happy for you to send them a copy with my permission and perhaps both you and the MOD will truly

believe I have the real thing on photo & video plus the paintings I did as well from two of the videos.

I have binders & folders of all or most UFO'S seen & claimed sine the first one that crashed in Mexico along with several cuttings from sightings by various people that make a report in the local and national papers.

Thank you for the record list of this years sightings so I'm going to try and get my dates of my lot to see if they were on the same dates as some in the list could be the same UFO or may not? As these things can travel the whole country in seconds.

### Faster Than Light

It was 2004, a summers evening in July, there was a little wind with large groups of clouds and larger clear sky separating them. I'd missed the last bus home from Bury to Bolton so had began walking at about 11.40pm.

Its a 15 mile walk to my home so by the time I got to the sighting area in Radcliffe, Greater Manchester, it must have been about 12.40pm. I'm unsure of the precise time because I don't use mobile phones or wear a watch. I was walking up Outwood Road towards Ringley Road, walking southwards. I was more than halfway up the long straight road when noticing clouds moving to the east which were slowly uncovering the nearly full moon. I thought to myself, "that looks nice," after watching for about 5 more seconds a sudden, bright flash of white light lit up the sky to my right and slightly in front of myself. I looked over to it then saw a streak/beam of fading light extend out from the flash from its lowest point on its easterly edge, moving to the east on a horizontal trajectory about half way up in the sky.

At the far left of that I saw a disc shaped craft, dark colour and which seemed to be slowing down its speed. Almost as soon as the beam of light disappeared for about 0.2 of a second it was covered in the heat/flames seen when a craft enters earths atmosphere. It continued slowing down then when the flames/heat disappeared it turned right and down into cloud cover. The time it took from the flash of light to when it went into the clouds was a little more than 2 or 3 seconds.

I looked across at the driver of a car who was to my left side and she too was looking into the sky with a big smile on here face.

The clouds it hid in where above the nearby city of Manchester, again facing me and was roughly south of me and to the East side of the moon, it was in front of me to the south again. I continued walking up the road then about 20 or 30 seconds later I saw a large jet diving out of high altitude which was becoming visible quite slowly. First I saw its bright red and green light, each being on the underside of each wing, then I saw the rest of the plane become visible as it got closer to me. When at the same level the strange craft had been it slowly levelled out then followed the same route into the clouds. I found a place to stand away from the road so I didn't look suspicious due to it being between 12 and 1 in the morning then waited to see what else would occur. I could hear the large jet but couldn't see it, the strange craft was totally silent throughout the sighting.

About one minute after the large jet entered the clouds it exited them from the other side and then turned right in a circle while lowering its altitude then re-entered the clouds. It continued with this corkscrewing down, in and out through the clouds for about 20 or 30 minutes when then a dark coloured, unmarked, small

ish streamlined helicopter arrived on the scene.

The jet was similar looking to a small passenger airliner jet but being dark coloured and unmarked. Or be the dark sky was preventing me from seeing any markings but it was a fairly well lit up night sky due to the near full moon which was now totally out of cloud cover.

The helicopter flew easterly under the clouds till I could no longer see it while the large jet then flew near me and then turned at me who was by now stood in a field watching while giving them a 2 fingered hand signal.

When the plane turned away from flying towards me I then reckoned they'd clocked me so walked the rest of the miles home.

Surely the strange craft was braking speed from above light speed before entering earths atmosphere then hid in the clouds knowing full well the military would be on their trail immediately. The crafts crew for sure appeared 5 to 8 seconds after I thought about the moon and clouds looking nice because well their craft capabilities looked nicer. It was by far the most amazing sighting id ever seen up till now in 2009 and all my sightings are amazing. And then the pilot skills and manoeuvres of his large jet were pretty impressive too but his equipment couldn't find the craft. Somehow he didn't know where it was and him corkscrewing his plane down, in and out of the clouds looked like he was using radar equipment to scan all around and in them clouds. Their attempts to track and follow it looked pathetic, I wonder at why do they even bother when this craft can travel faster than light, it entered earths atmosphere in less than half a second and turned 90 degrees in less than half a second and while travelling more than 2000 MPH.

Military and government aircraft are by a long way outclassed in every way and it's a similar scenario to compare their attempts at chasing and capturing an SFC to a guinea pig trying to catch a Ferrari which is half a mile in front. UK military they must be hoping to get lucky and the craft either breaks or crashes, that is if their fighter jets can't get hold of them.

The UK government haven't ever shared with the public all their SFC finds, evidences and witness statements from their airspace operatives who've seen these craft so for whatever reason they are trying to get one of these craft it isn't to help us the taxpayers. It's somehow to help themselves the government and it's easy to work out they want this technology for military purposes and to send their paper authority wherever in space these craft can take them.

SFC crew have reckoned to me loads of times that governments are always taking wild shots at their kinds, may be if they don't stop an SFC will fire back. It would be the first time governments have seen one shoot back and to me and SFC crew would just be classed as a self defence.

Above light speed they had to have been slowing down from, no other explanation can explain the flash and streak of fading light. And I've only heard of one plausible explanation how any craft or object could travel above light speed and that explanation entered my thoughts only after I asked (in thoughts) for SFC crew to explain how they travel at such speeds.

I did explain that earlier in this book but will mention it again here, they do that by almost instantly creating an object the length of the journey they are to travel, it appears at the back of the craft so propels it forward almost instantly.

They really do make sure I have lots to tell of themselves and it's usually of stuff not heard of before. It all started on this warm, sunny cloudless evening on the 8th August 1997 at 6. were just finishing our meal in the garden, then for some reason I glanced up at the sky just above the roof of our house, and saw what I thought at first was a cluster of silver balloons 8 in total of various sizes tethered together high in

somewhere towards the N.E.

Four of the objects were very large and kept together and the other 4 were much smaller about 4 times smaller and very white/silver in colour, three of them move to one side and formed a triange and the other one moved out to the other side in a fixed postion as they all moved upwards.

As I was trying to gather what direction the balloons were travelling, I saw them all moving apart again into fixed positions then move to another, which made me think balloons can't do that so precisely.

I said to my family to look up there at these balloons and tell me what do you see, my son of 22 & daughter of 19 looked and said they look like those silver foil balloons, as they were reflecting the suns rays, just like a prism does with rainbow colours.

Because they kept forming the same positions over and over again, then reforming into a tight group as they drifted over the sky, we became more suspicious of the first thought, and more convinced they were under some control.

I must point out we have never seen anything like this before, and we all know what balloons look like in the sky, as I used to sell & fly all kinds of balloons including silver foils, so we have some idea from our experiences over the years what to look for to identify the object and it's distance in relation to other things around.

But because it was a cloudless sky that day, there was only a number of gliders around to judge how high they were and the size of them, our opinion through binoculars was that they were very large of various sizes and very high in the sky, we estimated that they started off when I saw them at about a few hundred

I just share those three photos because I saw the news from CNN and it said I could send to your Ministry of Defense.

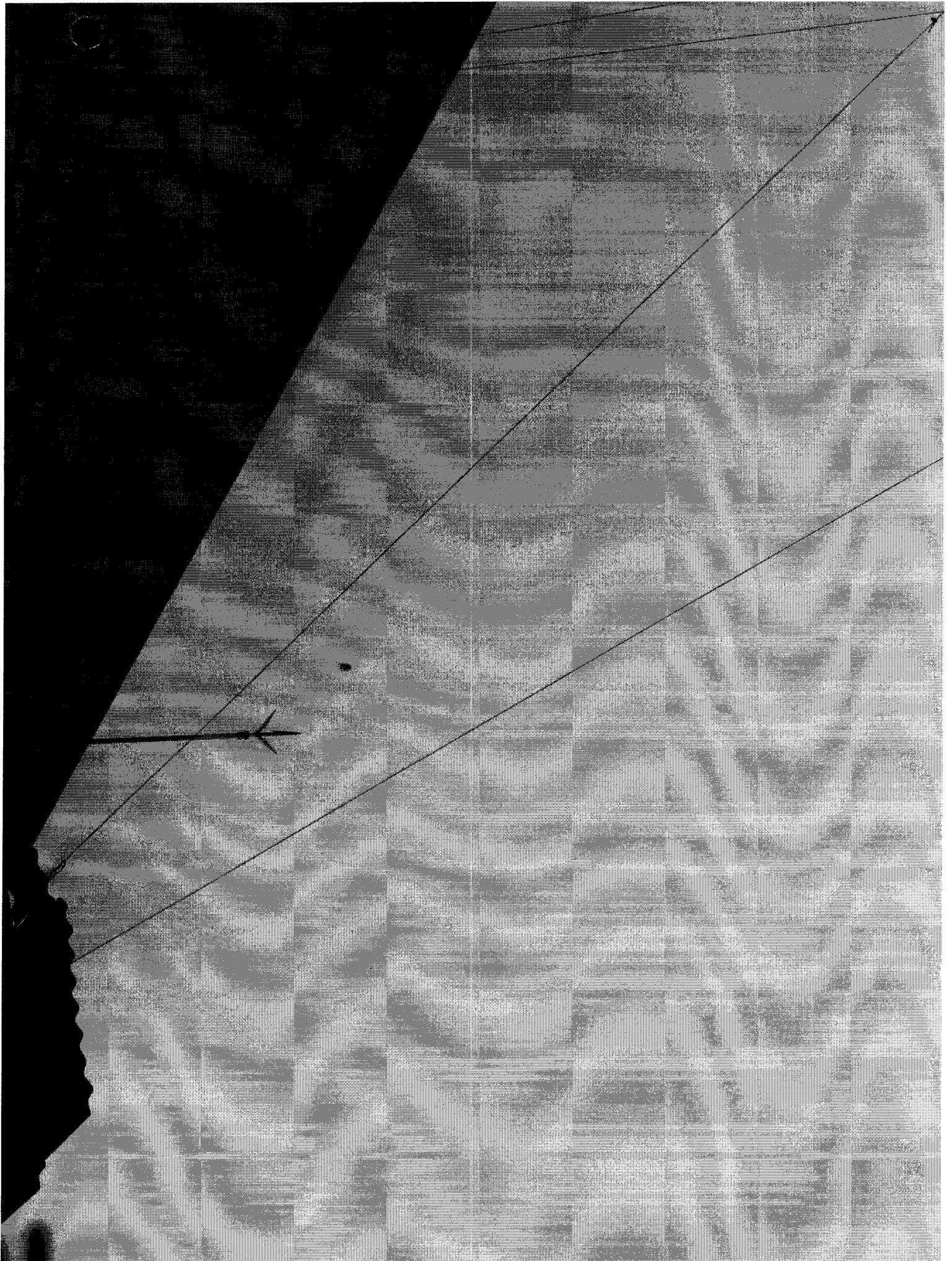

Anyway, this was the second time in my life I had seen the UFO (Unidentified Flying Object) at the vast wonderful sky. I love and I believe so much for it.

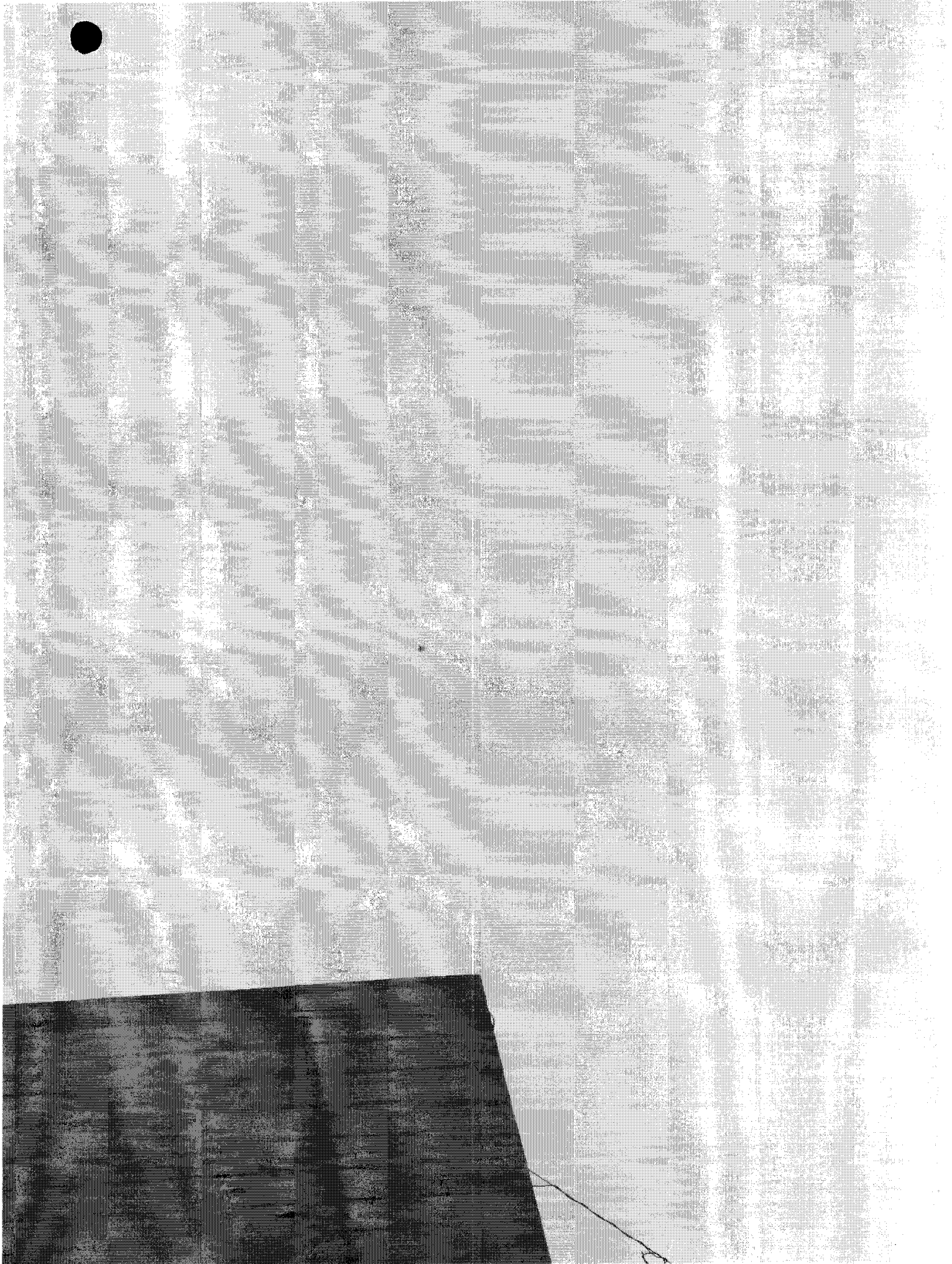

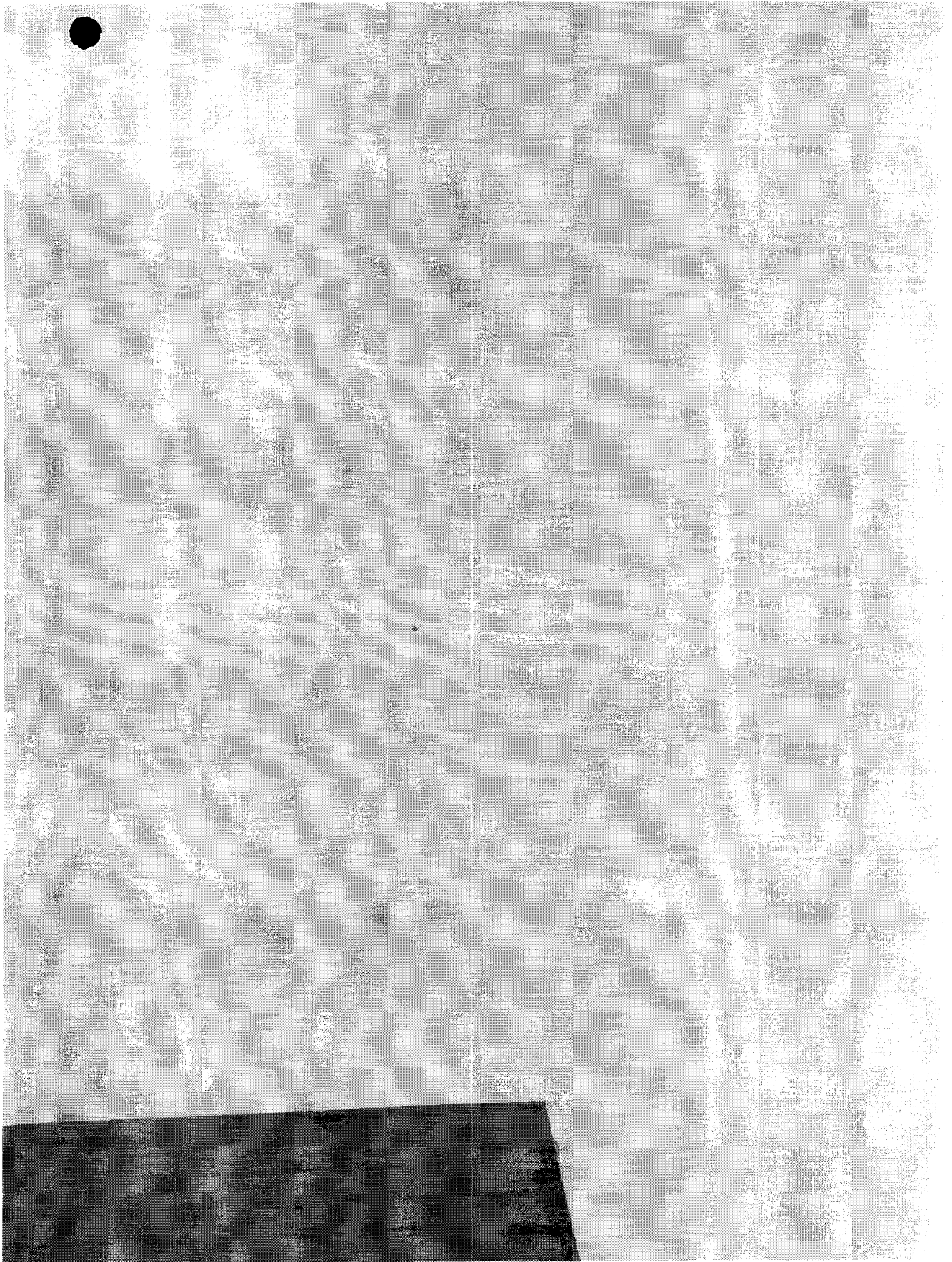

Thank you for your e-mail of 13 August concerning the UFOs you have seen.

Firstly, it may be helpful if I explain that the Ministry of Defence (MoD) examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorised air activity.

Unless there is evidence of a potential threat to the United Kingdom from an external source, and to date no UFO report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

The MoD does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial life forms, about which it remains totally open-minded. I should add that to date, the MoD knows of no evidence which substantiates the existence of these alleged phenomena.

We have noted your comments and have placed your e-mail on file.

## An unusual experience

I'm sure this will sound weird to you, just as it seems really strange to me to be putting it in writing after all this time.

Back in the summer of 1978 an event happened to me which I can recall in vivid detail. At the time it was quite terrifying and lasted for around 30 seconds and immediately afterwards a corroborating event lasted for about 60 seconds. This second event (I have always assumed) was intended to validate that the first actually happened. This event did not originate on Earth - this I am sure of.
