Dear Mr. President:

We, the members of the Project Starlight Coalition, a group of American and international citizens working to effect a public disclosure on the UFO/extraterrestrial issue, respectfully request the following:

That appropriate members of the administration meet with members of the Project Starlight Coalition to review significant evidence and witness testimony related to the subject.

That the President issue an executive order to release U.S. government witnesses from their national security obligations/oaths related to the subject so that they may provide public testimony.

That the President issue an executive order to declassify and release currently classified materials, documents and evidence related to the subject.

We feel that these requests are consistent with recent administration actions which resulted in the release of classified information related to the Department of Energy, intelligence satellite photographs, and other documents. We recommend that this matter be handled expeditiously and we respectfully look forward to your reply.






